Reflecting this, the Centre is committed to reaching its full potential in the coming years and we are delighted to have the continuing support from the University Board to realise this goal.

Since the evaluation, we have also completed the second phase of expanding the number of staff at IZO, and will now turn to implementing the recommendations of the German Council of Science and Humanities in areas where further improvement can be made. Reflecting this, this annual report gives a comprehensive overview of the diverse activities carried out within the Centre over the past academic year. It clearly illustrates that Frankfurt has become a vibrant place to study and to do research on the cultures and societies of East and Southeast Asia. We are grateful to all those whose critical support has made this possible.

I hope you will enjoy reading the report and learning more about the large variety of East Asian studies related activities in Frankfurt.

Review of academic year 2009/10

The past academic year was dedicated to the evaluation of IZO. Under mandate by the Ministry of Higher Education, Research and the Arts of the State of Hesse (Hessisches Ministerium für Wissenschaft und Kunst – HMWK), the German Council of Science and Humanities evaluated the development of centres for the humanities at the universities in Frankfurt am Main, Giessen and Marburg. In the course of restructuring the so-called "minority disciplines", the plan was to establish centres for East Asian, Eastern European and Oriental Studies at these universities in order to ensure the continuation of these disciplines with a regional focus and their corresponding programmes of study at universities in the State of Hesse. This strategy, which has been strongly supported by the State since 2006 in the form of additional funding, has generally proven to be a good instrument for the advancement of these disciplines.

The German Council of Science and Humanities Council report, published in May 2010, includes evaluations of the individual centres, as well as general recommendations for founding and developing similar centres. Moreover, the creation of centres in Hesse is envisaged to serve as an example for other German states to follow. One of the greatest challenges identified by the Council was on how to establish a sustainable balance between interdisciplinary and discipline-based research,

teaching and mentoring – a challenge that members of IZO will continue to face in the future. The existing approaches must still be further developed in order to transform the Centre during the coming years into a high profile and internationally visible and competitive centre for interdisciplinary research and teaching. In accordance with the recommendations of the Council, the State and the University Board will continue to provide financial support to facilitate the consolidation of IZO.

This semester, IZO members have already begun to implement the recommendations of the Council for the Centre. The framework for cooperation with the University Board has been set out in a target agreement for the years 2011 until 2015. In addition to individual research and cooperation with the University's internal and external partners, we envisage that interdisciplinary research will be intensified in the context of thematically focused research groups. In the future. IZO will also continue to contribute to the mission, concepts and methods of area studies research in Germany in cooperation with the other centres for area studies at Goethe University.

In the winter semester 2009/2010, the new postgraduate programmes "Japanese literature and history of thought" and "Sinology" were launched. The Sinology Master pro-

gramme includes a semester abroad at the European Center for Chinese Studies (ECCS) at Peking University, where participants are introduced to library and archive related skills. Furthermore, the new interdisciplinary English language Master programme "Modern East Asian Studies (MEAS)", demonstrates IZO's commitment to strengthening interdisciplinary teaching and learning provision. The programme is being offered jointly by the Faculty of Economics and Business Administration, the Faculty of Law, the Faculty of Social Sciences and the Faculty of Linguistics, Cultural and Civilization Studies, and is designed to offer students with a bachelor's degree in Asia-related cultural studies or economics and the social sciences with an interdisciplinary approach to East Asian economies, laws, and societies. This programme has attracted a great deal of interest with growing numbers of students enrolled in 2010/11.

The most significant changes, however took place in Korean Studies, which, thanks in no small part to the generous support of the Korea Foundation, now forms the fourth key research unit of the Centre. Joanna Elfving-Hwang was appointed as Junior Professor of Korean Studies starting in the summer semester 2010 and joined the Centre from Sheffield University. Hanna Schunka took up her post as the new Korean language instructor to further develop and strengthen the existing Korean language teaching provision. Yonson Ahn also joined in the summer semester and took

over as successor to Seon-Ho Jun as the Korea Foundation visiting professor for Korean culture and society until September 2011.

In the Southeast Asian Studies department, Arndt Graf, most recently from the Universiti Sains Malaysia (Penang), was named professor for the languages and cultures of Southeast Asia. He is now carrying on the authoritative tradition established by Bernd Nothofer in Frankfurt. The new dynamism has already gained broad visibility through hosting the international conference "Trade and Finance in the Malay World" (17-18 June 2010 in Frankfurt). During the winter semester 2010/11, the new Bachelor programme for Southeast Asian Studies "Languages and Cultures of Southeast Asia" will get underway, welcoming its first students either majoring or minoring in the subject. This first class will also benefit from the highly successful book donation campaign, "1,000 books about Southeast Asia".

In Chinese Studies, a professorship for political science with a focus on East Asian area studies is to be filled during the course of the winter semester 2010/11. In addition to the established teaching faculty, Chinese studies were also pleased to host Haijun Jin, a distinguished expert on Chinese intellectual property law from Renmin University, as a visiting professor during the winter semester 2009/10. A major conference on this subject was also held at IZO in early March 2010. At the BMBF (Federal Ministry of

Education and Research)-supported event, whose participants included representatives from German academic organisations and companies. Among presenters were also high-ranking representatives of the Chinese State Intellectual Property Office (SIPO) discussing the practical implications of the newly revised Patent Law of the PRC. Moreover Haoming Xu from the Chinese University of Political Science and Law, tought Chinese law at IZO during summer semester 2010. It is also worth mentioning that Sinology students Lydia Englberger and Henning Zander won the second place in the preliminary round of Germany's 9th National "Chinese Bridge (Hanyu qiao)" Competition in Trier.

In undergraduate Japanese Studies, students Michael Born and Christopher Derbort had success with their project "Gakumon" in the 2010 students' eLearning initiative (SeLF) at Goethe University. "Gakumon" aims to set up a virtual learning community for all students of Japanology, linking the already existing resources like the Japanology Forum or the "J-Wiki" to new eLearning methods, such as the University's "LernBar" portal and e-lectures. Among teaching staff, Guido Woldering was nominated by his students and awarded the "1822 and University Prize for Excellence in Teaching", in recognition of his teaching excellence in Japanese language and culture. On 30 April 2010, Ambassador Takahiro Shinyo held a lecture at IZO on Japanese diplomacy in a multi-polar world.

In May, Japanology and Sinology scholars held a colloquium and workshop on current topics in contemporary theatre in East Asia such as environmental disasters, unemployment and aging societies. In August 2010, for the first time in Germany, IZO held a summer school on Japanese law.

Since April 2010, adjunct professor Thomas Feldhoff, previously of the UHI Millennium Institute in the UK, has held the position of Coordinator and will continue to manage the affairs of the Centre. He has replaced Katrin Fiedler, whose excellent work in the development phase of the Centre, especially during the evaluation process, earned her a great debt of gratitude from the IZO members.

Mission of the Centre

The Interdisciplinary Centre for East Asian Studies (IZO) is a multi-disciplinary academic centre of the academic centre of Goethe University Frankfurt. The mission of the research and teaching programmes at IZO are to study the modern cultures and societies of China. Japan, Korea and Southeast Asia, as well as their historic roots, from the combined perspectives of a variety of disciplines. The primary concern is to strengthen interdisciplinary, theory-led research, based on solid language ability as a prerequisite for working with original language sources. The Centre formes an essential part of Goethe University's internationalisation strategy.

IZO offers a wide spectrum of approaches to East Asian studies: Culture and region-specific knowledge, as well as philological, historical and cultural methods, combined with those of the social sciences, law and economics and their related competencies. The Centre thrives to an intensive exchange with the international scientific community, and is especially known for its cooperation with scholars and academic institutions in East and Southeast Asia. It

develops approaches to competency building in East Asian languages, cultures, societies, economics, and law – primarily in the context of university education, but also for the larger societal sphere.

In addition, IZO combines academic theory and research findings with practical experience, especially through cooperation and exchange with institutions and representatives from the areas of culture, business and politics.

The primary objectives of IZO are:

- Theory- and method-based multidisciplinary research on East Asia, including dissemination of results, national and international networking as well as securing of external funding,
- Collaborative and inegrated teaching and learning provision in East Asian Studies to foster the development of young scholars within the university,
- Dissemination of East Asia-related academic findings to the public and increased public awareness of the relevance of East Asia-related research.



Courses and curricula

Degree programmes

BA-programmes in East Asian Studies

Students have been able to study toward a single honours BA in Sinology and Japanology since winter term 2006/2007. Each of these can be selected als major or minor subjects and freely combined with elective subjects from any disciplines. The distinguishing features of the Japanolov programme include the choice to take modules on economics and law in Japan in addition to cultural studies themes. Students enrolled on the programme Sinology spend a semester abroad in a Chinese-speaking country, usually at the European Centre for Chinese Studies (ECCS) at Peking University. The institutes of Sinology, Japanology and Southeast Asian Studies, as well as the Korean Studies institute offer also a strong contribution to the BA programme Empirical Linguistics in the Faculty of Linguistics, Cultural and Civilization Studies.

A new BA programme "Languages and Cultures of Southeast Asia" will be offered from winter term 2010/11. Building on the acquisition of solid language skills, students approach the object of study using tools from linguistics, literary studies and contemporary Southeast Asian studies.

Advanced programmes in Asian Studies

With four newly established MA programmes, the East Asian Studies institutes continue to offer attractive options for advanced degrees in Frankfurt:

- "Japanese literature and history of thought", which includes subjects such as historical and contemporary perspectives on ideas and thought in Japan, aesthetics and lifestyles, as well as discourses and ideological positions of Japanese intellectuals.
- "Sinology" with the three elective subject areas "Chinese com-

munication and language culture", "Chinese knowledge cultures" and "Social science approaches to Chinese academia (political relations in China)"

- Interdisciplinary, English-language Master programme "Modern East Asian Studies" (MEAS) with subsequent option to pursue a PhD
- "Empirical linguistics with a focus on the languages and cultures of Southeast Asia" including an intensive study of the Malaysian language

Interdisciplinary and international teaching projects

Interdisciplinary and international teaching projects located between various subject fields and/or university faculties have long been a part of East Asian Studies in Frankfurt. For the first time in September 2009, an archaeological summer school was held in China. In cooperation with the Institute for the History of Science at the Chinese Academy of Sciences, six students of Archaeology and Sinology had the opportunity to participate in Chengdu (Jinsha site).

In August of this year, in cooperation with the German-Japanese Association of Jurists (DJJV), a ten-day summer school on Japanese

law was held, which offered a condensed introduction to Japanese law and informed participants about the degree options and career prospects. Finally, the Japanology department is continuing its successful "Virtual Classroom" project, which makes video for joint e-Learning available to students of Japanese literature at Senshū University (Tokyo) and Japanology at IZO. Thanks to generous support from the University Board and external funding for enhancing excellence in teaching and learning Japanology is organising its first ever excursion to Japan with 15 students, which is being led by Cosima Wagner.

During a workshop in Frankfurt (25 September 2009), the concept that has been termed the "discovery of childhood" in Western Europe since the Renaissance was examined in the context of Japanese history. This formed the foundation for a panel on "Japanese childhoods" at the 14th German-speaking Conference of Japanese Studies in Halle (28 September 2009), where the model was analyzed for its viability in the case of Japan. The aim of the participants Susanne Formanek (Vienna), Eike Großmann (Frank-

furt), Michael Kinski (Frankfurt) and Harald Salomon (Berlin) was to identify and present examples of key topics from – predominantly Japanese – research for their respective periods of investigation, the Heian period (SF), Edo period (MK), Meiji period (EG) and early Shōwa period (HS). In relation to this, the issue of the material foundation for a critical analysis of the history of childhood and childhood imagery was discussed, and an attempt was made to provide a first overview of current research.

■ "The significance of modified Chinese patent regulations for German and European scientific organisations and companies", sponsored by BMBF, Goethe University, Frankfurt am Main, 01 and 02 March 2010

Chinese patent protection has gained a great deal of importance over the last few years. The Chinese

State Intellectual Property Office registers a considerable increase in patent applications annually. The

third amendment to patent law, which went into effect in October 2009, takes into consideration the growing significance of the patent system in the domestic context. Much stronger than the two previous amendments from 1992 and 2000, the primary purpose of which was to adapt Chinese patent protection to international guidelines, the objective of the latest changes adopted is to bring the Chinese patent system in line with domestic interests. However, many new rules may also impact directly on any engagement by German and

European scientific organisations and companies in China. The goal of the conference is to help representatives from local research institutions comprehend the significance of the modified regulations. Recognized Chinese and European experts in the field of science and patent practice gave lectures, among other topics, on new rules for the application, examination, and granting of patents, new patent requirements, comparative observations regarding patent infringement suits and patent protection limitations.

"Unleashed world(s)? Salvation and destruction scenarios in modern East Asian theatre". Colloquium with workshop organized by Eike Großmann (Japanology) and Mirjam Tröster (Sinology), sponsored by the Fritz Thyssen Foundation, 28 to 29 May 2010

Unleashed nature, unleashed mankind? It appears that since the 1990s the societies of Japan and China have been shaken down to their foundations: In Japan, a majority of society has been stunned by the attacks in the Tokyo subway system and the Hanshin earthquake. The feeling of deteriorating social structures made people call this period "Japan's lost decade". The Chinese government, on the other hand, is promoting the "harmonious society", while the deep fractures and inconsistencies in society become more and more evident. The way in which the catastrophic situation of the migrant workers or the disturbances in Tibet and Xinjiang were handled created an image of a government at loss.

"Unleashed world(s)?", an interdisciplinary colloquium with Japanologists, Sinologists and theatre scholars in May 2010



In a world that is increasingly perceived as frightening, the theatre is a place that can explore social phenomena. Theatres in China, Taiwan and Japan become not only a stage of utopian worlds, but also

of infernal horror. The presentations of Japanologists, Sinologists, and theatre scholars addressed works and productions of contemporary authors and directors such as Yôji Sakate, Toshiki Okada, Suzuki Matsuo as well as Zhaohua Lin, Shixing Guo and Katherine Hui-ling Chou, and discussed the portrayed social models.

Around 40 participants attended the first day of the colloquium. During the second day a practical theatre workshop held by Li Mo PhD (Waseda University, Tokyo) added another view on contemporary theatre in East Asia by introducing physical movements of so-called classical Japanese and Chinese theatre forms.

"Trade and finance in the Malay world: Historical and cultural perspectives", international seminar sponsored by the German Research Foundation, organised by the department of Southeast Asian Studies together with the Interdisciplinary Centre for East Asian Studies, the School of Humanities, Universiti Sains Malaysia, Penang, Malaysia, and the Department of Malay Studies, National University of Singapore, Frankfurt am Main, 17 to 18 June 2010

The department of Southeast Asian Studies under the direction of Arndt Graf together with partners from Malaysia and Singapore organised a conference on trade and finance in the Malay world. The (partial) replacement of indigenous merchant classes with foreign and immigrant merchants is one of the most significant impact of the colonial period on insular Southeast Asia. The

cultural consequences for the historic construction of the "Malay identity" were extensive and still influence the discourse in the post-colonial Malaysian world to this day. This international conference dealt with both the historic significance of this process and its representation in historic and modern discourse.

■ "Institutions put to the test – between inertia and adaptability", 4th workshop in the series "Institutions in the development of East Asia", in advance of the conference "Economics in crisis?", Evangelische Akademie Tutzing, 10 March 2010

The event was held for the fourth time in cooperation with the Evangelische Akademie Tutzing. Addressing the topic with a variety of methodical approaches, the participants examined the institutional inertia and adaptability often seen as "typical" for East Asian countries. The topics covered included Chinese state capitalism, the decrease of coordination in the Japanese economy, and FDI activities of Japanese firms in Eastern Europe, based on own empirical analysis. As in the past years, the workshop was

organised by Cornelia Storz together with Prof. Dr. Werner Pascha and Prof. Dr. Markus Taube (University of Duisburg-Essen) and it was part of a larger conference held from 10 to 12 March 2010 by the Evangelische Akademie Tutzing. It offered the opportu-

nity for intensive exchange between economists and social researchers interested in similar methodological or theoretical issues. The next workshop is to be held on 16 March 2011. For further information contact: storz@wiwi.uni-frankfurt.de.
