Translation of the discipline-specific regulations for the Master's programme in Southeast-Asian Studies as "one-subject-Master" at the Faculty of Linguistics, Cultures, and Arts of the Johann Wolfgang Goethe University of Frankfurt

(Please note that only the German version of these regulations is legally binding!)

Part I. General remarks

I.1.1 Scope of application of these discipline-specific regulations

The general regulations for Master's programmes in the Faculty of Linguistics and Cultural Studies at the Johann Wolfgang Goethe University (dating from 17.12.2014) and the general regulations for consecutive and modulised programmes at Goethe University Frankfurt (dating from 30.04.2014) in their respectively applicable versions, are a component of these faculty-specific regulations.

I.1.2 Aims of the programme and purpose of the examination

The Master's programme in Southeast Asian Studies (SEAS) is research-focused and aims to enable students to undertake autonomous research at an advanced level. The programme deepens and complements methods learned during the Bachelors programme and empowers students to reflect on these methods critically, to deal with theoretical concepts in the field of study and to relate them to generally discussed theories and research developments. Students are trained in cultural studies analysis and academic work.

With regard to content, the programme focuses on a philological / cultural studies-based examination of the Malay world (Indonesia and Malaysia, as well as Brunei Darussalam, Singapore and East Timor).

In particular, the programme comprises the teaching of the following expertise, methods and skills:

- advanced reading and communication skills in Bahasa Indonesia and Bahasa Malaysia respectively, by examining topics and discourses on Southeast Asian cultures and societies in literature, art, and mass media, on the basis of original language sources on current developments,
- a considered approach to data, sources, texts and methods relating to Southeast Asia,
- familiarity with current research questions, debates, and academic methods in Southeast Asian Studies,
- general key competences and their specific application in an academic context
- intercultural competence and the ability to critically reflect on culturally-determined perspectives, both one's own and those of other cultures

Students can choose between two versions of the study programme: with an included semester abroad (version 2) or without a semester abroad (version 1).

For students of version 1 the "elective modules" allow the development of an individual study profile, for example for the following three suggested specialisations:

- classical philology and history of the Malay world
- modern language application and society in the Malay world
- culture and economy in Southeast Asia

I.1.3 Professional spectrum

The programme qualifies students for a broad professional spectrum. It prepares students for Southeast Asian-related academic activities, including the following:

- · academic research and teaching
- academic and cultural exchange / management
- publishing industry, media, journalism
- politics: diplomatic service, ministries, political parties
- economy: for example, industry and trade, international economics, banking, consulting, Chamber of Industry and Commerce (IHK), Association of German Chambers of Industry and Commerce (DIHT)
- interpreting and translating
- education: professional training, language teaching
- librarianship

I.1.4 Standard Period of Study

The standard period of study, including all examinations and Master's thesis, is four semesters. It is possible to finish the study programme earlier.

I.2 Programme commencement and prerequisites for admission

I.2.1 Programme commencement

The Master's programme in Southeast Asian Studies can only be commenced in the winter semester.

I.2.2 Prerequisites for admission

- (1) General Prerequisites for admission are
 - a) A Bachelor's degree in Southeast Asian Studies or comparable disciplines at Goethe University with a standard programme duration of at least 6 semesters, or
 - b) a degree of at least equivalent value from a German university or German institute of higher education in a similar or related discipline with a standard programme duration of at least 6 semesters (see 2), or
 - c) a degree of at least equivalent value from a foreign university in a similar or related discipline with a standard programme duration of at least 6 semesters (see 2), or
 - d) a Bachelor's degree in another discipline in the humanities or social sciences with a standard programme duration of at least 6 semesters (see 2).
 - e) In addition: Detailed CV providing information about the applicant's interest in the Southeast Asian Studies programme must be handed in with the application.
- (2) In cases b), c), and d) admission to the programme can be allowed by the Examination Committee provided the applicant has an adequate command of Bahasa Indonesia (or Bahasa Malaysia) and a general familiarity with the Southeast Asian region. The Examination Committee reserves the right to impose conditions for foreign-discipline applicants, such as additional Indonesian language courses or additional seminars on languages and cultures of Southeast Asia, which provide the applicants with fundamental knowledge on Southeast Asian history, society, and culture. This must be completed within the first two semesters after enrolment. § 8 (3) MA09 applies.
- (3) In general, the language of instruction for the Master's programme is English. As the programme can be studied completely in English, a German Language University Entrance Examination (DSH) according to § 8(5) of the General Regulations for Masters Programs in Faculty 09 is not required. Applicants for the programme should be made aware that it is nevertheless preferable to have a basic knowledge of German language, since in-and outside the university much relevant information is available in German only.

I.2.3 Language competences

1) Additional prerequisites for admission is proof of an adequate command of English, comparable to level B 2 of the "Common European Framework of Reference for Languages" (CEFR) (dating September 2000). Proof of language skills can be provided by:

- a) Abitur
- b) Upper school certificate or proof of at least five years of English language learning at school or
- c) UNIcert degree, level 2
- d) TOEFL test (internet based, score of 87 points or more), or
- e) certificates regarding another proof accepted as equivalent by the Examinations Committee
- b) In addition, proofs for adequate command of Bahasa Indonesia or Bahasa Malaysia must be provided. Students with a Bachelor's degree involving little or no knowledge of Indonesian or Malay must provide proof that their language skills are at least equivalent to the level attained in the Bachelor's programme "Southeast Asian Languages and Cultures" (Sprachen und Kulturen Südostasiens) following successful completion of Bahasa Indonesia introductory course modules SKS 1 and SKS 2, or, alternatively, to at least 200 hours' language study at a university level. Proof of language skills can be handed in later; at the latest, it must be provided together with the application for admission to the Master's examination. Until then the enrolment is conditional only, according to § 54 (4) of the Higher Education Act of the State of Hessen (Hessisches Hochschulgesetz). Proof may be effected by the following means:
 - a) expert report or test of language skills acquired in the course of time spent abroad, university language courses, or private study; or
 - b) ... completion of a written examination parallel to the abovementioned module examination for the Bachelor's programme; or
 - c) ... other certificates accepted as equivalent by the Examinations Committee.

Part II: Course structure and examination administration

II.1 Course structure and scope

(1) The Master's programme comprises 120 CP. Depending on the version (1 or 2), the structure is as follows:

Version 1 (without semester abroad):

- a) 54 CP for the four compulsory modules (SEAS 1-4)
- b) 36 CP (3 x 12 CP) for three elective modules (to be chosen out of SEAS 5-9)
- c) 30 CP for the Master's thesis.

Version 2 (with semester abroad):

- a) 54 CP for the four compulsory modules (SEAS 1-4), plus 6 CP for module SEAS 10
- b) 30 for SEAS 11 (= semester abroad)
- c) 30 CP for the Master's thesis.
- (2) The Faculty Council (Fachbereichsrat) may decide to limit the availability of elective modules if teaching capacity is insufficient. Students must be advised promptly of any such limitation.
- (3) Students may change an elective module only if they have not already definitively failed an examination in the previously selected elective module. Failed attempts are counted.
- (4) In accordance with the module description, classes in the Master's programme shall be held in English, German or Indonesian. Elective classes offered only in German are not available to students without German university entry qualifications or the German Language University Entrance Examination (DSH); this applies in particular to the beginners language courses in Thai, Vietnamese, and Dutch, offered within the elective module "Regional Expertise". If there is a choice between English- and German-language classes, the abovementioned students may select only English-language classes. This applies particularly to classes offered within the elective module "Free Studies" (Studium Generale) and workshops that can be counted towards Section 2.3 ("Scientific Practice and Soft Skills") of the module "Theories and Methods".

II.2 Course achievements

According to the module descriptions non-graded course achievements are obtained in following ways: written examination, literature review, minutes, presentation or written report.

Part III: Master's examination

III.1 Initial registration and admission to the examinations

For admission to the Master's examination the declarations and proofs as mentioned in § 14 MA09 have to be submitted.

III.2 Scope of the Master's examination

- (1) For students of version 1 the Master's examination consists of four compulsory modules (SEAS 1-4), three elective modules (to be chosen out of 5-9) and the Master's thesis.
- (2) For students of version 2 the Master's examination consists of six compulsory modules (SEAS 1-4 and SEAS 10-11) and the Master's thesis.

III.3 Master's thesis

- (1) The Master's thesis allows the student to demonstrate that he/she is able to deal independently with a linguistic, cultural or social problem relating to Southeast Asia within a set timeframe using academic methods.
- (2) Successful completion of modules amounting to at least 60 CP is a prerequisite for admission to the Master's thesis. 30 CP are awarded for the Master's thesis, which must be completed within a timeframe of six months.

III.4 Composition of final grade

The overall grade for the Master's examination is calculated from the average of the module grades, with the grade for the Master's thesis being counted twice.

III.5 Final grade "passed with distinction"

The overall grade "passed with distinction" is awarded if all graded pieces of work receive the grade "very good" (sehr gut) (1,0).

Part IV: Entry into force

- (1) These discipline-specific regulations enter into force on the day after their publication in the UniReport of the Johann Wolfgang University. The regulations apply as of winter semester 2017/18.
- (2) These discipline-specific regulations are valid for all students, who started the Master's programme in Southeast Asian Studies as of winter semester 2017/18.
- (3) Students who started the Master's programme in Southeast Asian Studies before legal validity of these discipline-specific regulations, are allowed to take the Master's examination according to the regulations for the Master's programme in Southeast Asian Studies dating from 25.04.2012 (UniReport: 18.11.2012). It is not possible to change to the programme that is described in these discipline-specific regulations.

The colloquium offers students an opportunity to present and discuss their work schedules with other students, to exchange views on the concrete application of theories and methods and to experience scholarly teamwork. This, in combination with the project 'Scientific Practice and Soft Skills', helps students to acquire key transferable skills valuable both for further academic work and for non-academic professions.

CP for 'Scientific Practice and Soft Skills' can be obtained in different ways, focusing on varying competences, e.g.:

- Teaching training tutoring or mentoring Bachelors students
- Practical academic experience conference participation, organising meetings or exhibitions, publishing
- Participation in Soft Skills workshops (e.g. at the 'Zentrum für Weiterbildung'; availability depends on course programme and language skills)
- Involvement in university policy and committee work

Students are strongly advised to discuss the evaluation of the abovementioned achievements with the Module Coordinator in advance, in order to evaluate the workload and the CP to be awarded, and, if necessary, to determine the form of assessment.

Learning objectives and competences

- Attainment of methodological competence, primarily with regard to independent empirical research and the ability to reflect critically on the dominant theories and methods of the student's field of study
- Preparation of the Master's thesis
- Opportunity to practice important academic skills and organise independent activities
- Acquisition of key transferable skills for personal development

- Comprehension of characteristics of different legal traditions and their contingency upon and effects on the relevant sociocultural context, as well as a familiarity with theory and method in law
- Theory and method of economics using Asian examples
- Theory and method of the social sciences in an introductory class to sociology or politics on Asia

Students of version 2 spend one semester at a university abroad. Students who have never resided for a longer period in a country in Southeast Asia, should spend their semester abroad in this region. Students from Southeast Asia or students who have been in Southeast Asia already for a longer period (at least four months), and therefore already have a general familiarity with the Southeast Asian region, are allowed to spend the semester at a university outside of Southeast Asia as well.

Besides visiting courses at the guest university, students have the possibility (in addition) to do either an internship in Southeast Asia or a research project during the semester abroad.

The conclusion of the module has to be attested by the person module coordinator (Modulbeauftragte/r).

Learning objectives and competences

The learning objectives and competencies depend heavily on the courses and internships/research projects chosen by the student. In general, the following competencies are developed:

- Improvement of foreign language skills
- Practical experience, practical application of key skills
- Gaining practical experience abroad; acquisition of intercultural and communication competencies (important for job positions in and outside of the university)

Students who would like to spend a semester abroad should contact module coordinator and student counselling as early as possible in order to discuss the following issues: planning, organisation, financing and possible places/universities for the semester abroad. However, it should be noted that students are fully self-responsible for the realisation and financing of their semester abroad.
